

## Appendix 2 Service Fees

**1) “one-off” Joining fee** CHF 800

**2) Annual fee** CHF 1'300

The annual fee is charged per service (CHF 1'300 for ONP Contract + CHF 1'300 for INA Contract).

The annual fee is charged once per year in January for the current year.

If the User joins after 1 July of a year, a reduced Annual fee of CHF 650 per service will be billed for the joining year shortly after signing the contract.

In the case a User has other NPRNs under the same company name, a reduced annual fee of CHF 650 will be charged per service on the additional NPRNs.

Exception: OFCOM is not required to pay the Annual fee.

### 3) Transaction based fee

Note that the transaction-based fees don't apply to read-only TSPs, who use only the “Query Service”.

#### a) ONP-Service

- Per “Work Orders ported in” with the Status OK (successful as recipient) CHF 0.30
- Per “Work Orders ported out” with the Status OK (successful as donor) CHF 0.30
- Per “Work Orders” with the Status CANCEL (cancelled as recipient) CHF 0.30

The ONP transaction-based fees are charged twice per year normally in January and July for the previous period. The charging period is of 6 months. The first invoice contains all transactions between 1 January and 30 June, and the second invoice contains all transactions between 1 July and 31 December.

Dependent on the Connection Type (e.g. Single Line, DDI, Value Added Services), several numbers can be involved on one Work-Order (see [15] Appendix 4).

Note that a special process for “mass portability” or “NPRN Migration” is available (see [15] Appendix 4) and its fee is determined on a case-by-case basis by Teldas. Before launching this process, the User can request a quotation from Teldas. Each line in the mass migration file is defined as „porting transaction“, with a minimum and maximum total price for the mass porting transaction comprised between CHF 2'000 and CHF 8'000.

#### b) INA-Service

- Per Number activation CHF 5
- Per Number Modification (tariff change) CHF 5
- Per Number in service with a non-online tariff on 31.12 CHF 5
- Per Tariff creation CHF 150
- Per Urgent Transaction CHF 100

The INA transaction-based fees are charged once per year, normally in January for the previous year. The charging period is of one year.

#### **4) Interest rate for late payment**

A User in arrears is liable to default annual interest of 5% for late payment as of due date, as well as an amount of CHF 40 for reminder charges.
